RESOLUTION DECLARING A FAILURE OF BIDDING FOR BID REFERENCE NO. 2020-46 ENTITLED "REHABILITATION, UPGRADE AND IMPROVEMENT OF THE MACHINERIES, REFRIGERATION SYSTEM AND EQUIPMENT OF THE KOREA-PHILIPPINES SEAFOOD PROCESSING COMPLEX AT THE BFAR-NIFTDC"

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project under Purchase Request (PR) No. 20-11-1072, with the purpose: "Rehabilitation, Upgrade and Improvements of refrigeration system, machineries and equipment to maintain the HACCP & FDA standard requirements of the KP-SPC facilities and to maximize fish processing capacity, compliant with the global food safety and traceability standards and amounting to one million pesos (Php 1,000,000.00) only;

WHEREAS, the said project was posted in the Philippine Government Electronic Procurement Service (PhilGEPS), the Bureau's website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;

WHEREAS, on December 04, 2020 the Pre-Bid Conference was conducted via Zoom and was participated by the following bidders, namely;

1. Joel Nicerio- FABJ
2. Joeross Rosete- Packware Philippines

WHEREAS, the opening of bids was conducted last December 16, 2020, 10:30 am at the BAC Conference Room 3rd floor, PCA Bldg., Elliptical Road, Diliman, Quezon City;

WHEREAS, only FABJ manifested their interest to participate;

WHEREAS, during upon checking of submitted documents, FABJ was declared disqualified due to the non-compliance with their NFCC amounting to Php 6,876,915.00 which is not sufficient for the ABC amounting to Php 20,000,000.00;

WHEREAS, the said bidder was given three (3) calendar days to submit a Motion for Reconsideration and the BAC Secretariat proceeded with the sealing of bids due to their disqualification;

WHEREAS, Section 35. 1 of the IRR of RA 9184 states that:

35.1. The BAC shall declare the bidding a failure when:

- a) *No bids are received;*

b) All prospective bidders are declared ineligible;

c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of consulting services, there is no successful negotiation; or

d) The bidder with the LCRB, HRRB, SCRB or SRRB refuses, without justifiable cause, to accept the award of contract, and no award is made in accordance with Section 40 of the Act and this IRR.

WHEREAS, based on the foregoing, the BFAR BAC resolves that the said project fall under subsection (b) of the afore-quoted provision of law.


NOW THEREFORE, the BFAR-BAC hereby it resolved as it is hereby resolved the following:



Declaration of Failure of bidding for the **Rehabilitation, Upgrade and Improvement of the Machineries, Refrigeration System and Equipment of the Korea-Philippines Seafood Processing Complex at the BFAR-NIDTFC** due to non-eligibility on the submitted bids by the Lone Bidder and to undergo the Re-bidding procedure with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.




