The Bureau of Fisheries and Aquatic Resources (BFAR), through the General Appropriations Act for 2021 intends to apply the sums of **THIRTEEN MILLION SIX HUNDRED FIFTY-FIVE THOUSAND THREE HUNDRED SIXTY-SEVEN PESOS AND 43/100 (PhP 13,655,367.43)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Bid Reference No. 2021-03A (Re-Bidding)** entitled **PROCUREMENT OF FLEET CARDS FOR FUEL (GASOLINE /DIESEL), OIL, LUBRICANTS AND OTHER SERVICES FOR BFAR CENTRAL OFFICE AND NATIONAL CENTERS FOR FY 2021 (FROM JUNE TO DECEMBER 2021)**.

3. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), now invites bids for the above Procurement Project. Delivery of the Goods shall be in accordance with the delivery schedule under Section VI, Schedule of Requirements. Bidders should have completed, within *two (2)* years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II or Instructions to Bidders.

4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is *restricted* to *Filipino* citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

5. Interested Bidders may obtain further information from the procurement activity given below and inspect the Bidding Documents at the address given below.
6. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a non-refundable Bidding Document fee in the amount stated above. It may also be downloaded free of charge from the website of Philippine Government Electronic Procurement System (PhilGEPS) and BFAR, provided that Bidder shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
7. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR) will hold a Pre-Bid Conference using “**Zoom**” application which shall be open to interested bidders. Please see the table below.

The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
