“SUPPLY AND DELIVERY OF VARIOUS PARTS, MATERIALS AND LABOR FOR THE REPAIR AND MAINTENANCE OF DA-BFAR VESSELS.”

1. The Bureau of Fisheries and Aquatic Resources (BFAR) of the Department of Agriculture, through the General Appropriations Act for 2021 intends to apply the sum of **SEVENTEEN MILLION EIGHT HUNDRED SEVENTY SEVEN THOUSAND EIGHT HUNDRED FORTY SEVEN PESOS (PHP 12,877,847.00)** being the ABC to payment under the contract for **Bid Ref no. 2021-17** entitled **“SUPPLY AND DELIVERY OF VARIOUS PARTS, MATERIALS AND LABOR FOR THE REPAIR AND MAINTENANCE OF DA-BFAR VESSELS.”**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Bureau of Fisheries and Aquatic Resources (BFAR) of the Department of Agriculture now invite bids for the above Procurement Project. Delivery of the Goods is required for a period within the period stated in the Section VI - Schedule of Requirements. Bidders should have completed, within the years stated in the ITB

Clause 5.3 from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information the procurement activity given below and inspect the Bidding Documents at the address given below.
5. A complete set of Bidding Documents may be acquired by interested Bidders at 3rd Floor, BAC Office, Elliptical Road, Diliman, Quezon City and upon payment of a non-refundable fee for the Bidding Documents in the amount stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees through electronic means.
6. The Bureau of Fisheries and Aquatic Resources (BFAR) of the Department of Agriculture will hold a Pre-Bid Conference¹ on **June 30, 2021 at 11:00 a.m** via video conferencing through “Zoom” application which shall be open to prospective bidders who have successfully completed the registration in Google form for at least one (1) calendar day prior to the pre-bid conference via <https://forms.gle/9PassK7oCipk8iXD6> and in accordance with the “**Annex A, Bidder’s Kit – I**”.
7. Bids must be duly received by the BAC Secretariat through electronic submission in accordance with the BFAR-BAC procedure for online bidding as stated in the “**Annex A, Bidder’s kit II to VI**” simultaneously with the submission of the printed copies as indicated in the **BDS Clause 15**.

The Bidder shall submit bids on or before **July 13, 2021 at 10:30 a.m** at the **BFAR-BAC Office, 3rd fl., PCA Main Bldg., Elliptical Road, Diliman, Q.C.**, and bac.eps@bfar.da.gov.ph.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.

9. Bid opening shall be on **July 13, 2021 at 11:00 a.m** via video conference through “Zoom” application. Bids will be opened in accordance with the BFAR BAC procedure for online bidding as stated in the “**Annex A, Bidder’s kit VII**”. Late bids shall not be accepted.
10. Bidders are advised to familiarize themselves with the BFAR BAC procedure for online bidding as well as for the printed copies as provided under ITB Clause 10 and Clause 11.
11. The Bureau of Fisheries and Aquatic Resources (BFAR) of the Department of Agriculture reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
