The **Bureau of Fisheries and Aquatic Resources (BFAR)** of the Department of Agriculture, through the General Appropriations Act for 2017 intends to apply the **TWENTY MILLION FIVE HUNDRED FIFTY TWO THOUSAND EIGHT HUNDRED EIGHTY PESOS (Php 20,552,880.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **“SUPPLY, DELIVERY AND INSTALLATION OF SYSTEM FURNITURES, OFFICE CHAIRS & CUSTOMIZE FURNITURE’S FOR NFRDI BUILDING.”**

2. The DA-BFAR now invites bids for Goods Indicated above. Delivery of the Goods is required within ***One hundred eighty (180) Calendar days***. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the procurement activity given below and inspect the Bidding Documents at the address given below.
5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount for **lot 1 TWENTY THOUSAND PESOS (Php 20,000.00)** It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
