The Bureau of Fisheries and Aquatic Resources (BFAR) of the Department of Agriculture, through the General Appropriations Act for 2020 intends to apply the sums of **EIGHT MILLION FOUR HUNDRED NINETY NINE THOUSAND NINE HUNDRED NINETY SEVEN PESOS AND FORTY FOUR CENTAVOS (Php 8,499,997.44)** being the Approved Budget for the Contract (ABC) to payments under the contract for **“SUPPLY AND DELIVERY OF FLEET FUEL CARDS FOR DIESEL, GASOLINE, OIL, LUBRICANTS AND OTHER SERVICES FOR BFAR CENTRAL OFFICE AND NATIONAL CENTERS.”**
2. Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. The DA-BFAR now invites bids for GOODS indicated above. Delivery of the Goods is required upon notification by the end-user for a period of Five (5) months from August to December 2020. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
5. Interested bidders may obtain further information from the procurement activity given below and inspect the Bidding Documents at the address given below.
6. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount stated above.  
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
