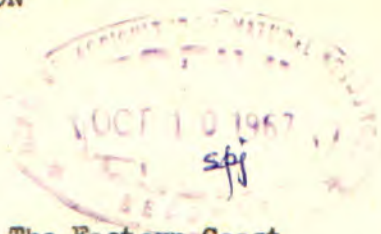

ORDER NO. 90



SUBJECT: Reserving Certain Marine Area Along The Eastern Coast of Pangap Island, as Government Farm for Sponge and Pearl Culture.

1. Pursuant to the provisions of Section 74 of Act 4003, as amended, a certain portion of marine waters along the eastern coast of Pangap Island, Tubigon, Bohol, is hereby reserved and declared government farm for sponge and pearl culture and production purposes.

The area is technically described as follows:


An area of about 1.0 square kilometer, being the body of water facing the eastern coast of Pangap Island, starting from station 1, at Lat.  $10^{\circ}00'27''$ , Long.  $123^{\circ}56'18''$ , thence to Sta. 2 with dist. of 500 meters, at Lat.  $10^{\circ}00'27''$ , Long.  $123^{\circ}56'36''$ , thence to Sta. 3, dist. 1,000 meters, at Lat.  $10^{\circ}00'00''$ , Long.  $123^{\circ}56'52''$ , thence to Sta. 4, dist. 1,000 m. at Lat.  $9^{\circ}59'32''$ , Long.  $123^{\circ}56'36''$ , thence to Sta. 5, dist. 500 m., at Lat.  $9^{\circ}59'32''$ , Long.  $123^{\circ}56'18''$ , thence to Sta. 6, dist. 1,000 m., at Lat.  $10^{\circ}00'00''$ , Long.  $123^{\circ}56'36''$ , thence to Sta. 1, dist. 1,000 m.

2. The above mentioned Government farm is hereby placed under the administration and control of the Commissioner of Fisheries who may apply the pertinent rules and regulations necessary to carry into effect the purposes of this Order; Provided, however, that in case there are no available funds and technical personnel to be used in the operation and/or maintenance of said farm, he may recommend to the Secretary of Agriculture and Natural Resources that the privilege to undertake the pearl culture and production in the aforesaid farm, be let under concession to any person, association or corporation qualified under the Fisheries Act to transact business in the Philippines.


3. Fishing or taking of any kind of marine products within the described marine area for commercial purposes is hereby prohibited subject to the penalties prescribed under Section 83 of Act 4003, as amended.

4. This order shall take effect upon approval.
