1. The Bureau of Fisheries and Aquatic Resources (BFAR) of the Department of Agriculture now invites bids for the above Procurement Project. Delivery of the Goods is required within the period stated in the Section VI - Schedule of Requirements. Bidders should have completed, within **TWO (2)** years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- 2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 3. Prospective Bidders may obtain further information the procurement activity given below and inspect the Bidding Documents at the address given below.
- 4. A complete set of Bidding Documents may be acquired by interested Bidders at 3rd Floor, BAC Office, Elliptical Road, Diliman, Quezon City and upon payment of a non-refundable fee for the Bidding Documents in the amount stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by in person, or through electronic means.
- 5. The DA-BFAR will hold a Pre-Bid Conference¹ on April 16, 2021 1:30 P.M. at BAC Conference Room, Elliptical Road, Diliman, Quezon City and/or through video conferencing via Zoom application which shall be open to prospective bidders. who have successfully completed registration one (1) calendar day prior to the Pre-bid Conference using Google Form PRE-REGISTRATION FORM (google.com) and in accordance with the "Annex A, Bidder's Kit I".
- 6. Bids must be duly received by the BAC Secretariat through Electronic submission in accordance with the BFAR BAC procedure for online bidding stated in "Annex A Bidder's kit II to VI" simultaneously with the submission of the printed copies as indicated in the BDS Clause 15.
 - The Bidder shall submit bids on or before **April 28, 2021 (Wednesday)**, **10:30 am**, at the **BFAR-BAC Office**, **3rd flr.**, **PCA Main Bldg.**, **Elliptical Road**, **Diliman**, **Q.C.**, and electronic documents through **bac.eps@bfar.da.gov.ph**.
- 7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
 - 8. Bid opening shall be on April 28, 2021 (Wednesday), 11:00 am, BAC Conference Room, Elliptical Road, Diliman, Quezon City and/or through video conferencing via Zoom application. Bids will be opened in accordance with the BFAR BAC procedure for online bidding as stated in the "Annex A, Bidder's kit VII". Late bids shall not be accepted.
