**INVITATION TO BID FOR:
BID REFERENCE NO. 2021-10
“REPAIR AND REHABILITATION OF CATFISH HATCHERY AT
BFAR-NIFTC TANAY, RIZAL”**

1. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), through the Bayanihan to Heal As One Act (Bayanihan II) for FY 2020 intends to apply the sum of **Two Million Four Hundred Thousand Pesos (Php 2,400,000.00)** being the ABC to payment under the contract for **Bid Reference No. 2021-10** entitled **“REPAIR AND REHABILITATION OF CATFISH HATCHERY AT BFAR-NIFTC TANAY, RIZAL”**.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), now invites bids for the above Procurement Project. Completion of the Works is required within Thirty (30) calendar days upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non- discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. And in accordance with the procedural guidelines under BAC Resolution No. 2020-55, attached hereto as Annex A “Adoption of Guidelines for the Electronic Submission of Bids in accordance with GPPB Resolution 09-2020”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital

stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the BFAR BAC Secretariat through electronic mailing address given below, and inspect of the Bidding Documents at www.bfar.da.gov.ph.
5. A complete set of Bidding Documents may be acquired by interested Bidders at **3rd Floor, BAC Office, Elliptical Road, Diliman, Quezon City and/or through electronic means** and upon payment of a non-refundable fee for the Bidding Documents in the amount stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by in person, or through electronic means.
6. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), will hold a Pre-Bid Conference¹ through a video conference call using Zoom application on **April 26, 2021 (Monday), 11:00 AM.** which shall be open to prospective bidders who have successfully completed registration one (1) calendar day prior to the pre-bid conference using Google Form which can be accessed through this link https://docs.google.com/forms/d/e/1FAIpQLSculZ4qcO6wDbeizhODN5b9IE9PiITjhbdH80-fUosjzjInDg/viewform?usp=pp_url
7. Bids must be duly received by the BAC Secretariat through electronic submission in accordance with the BFAR BAC procedure for online bidding stated in Annex A simultaneously with the submission of the printed copies as indicated in the BDS Clause 15. The deadline of manual submission and receipt of bids is on **May 10, 2021 (Monday), 10:30 A.M.** at the **BFAR BAC Office, 3rd flr., PCA Main Bldg., Elliptical Road, Diliman, Q.C;** while the electronic documents shall be submitted at the bac.eps@bfar.da.gov.ph
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
9. Bid opening shall be held through a video conference call using Zoom application on **May 10, 2021 (Monday), 11:00 A.M.** Bids will be opened in accordance with the BFAR BAC procedure for online bidding stated in Annex A. Late bids shall not be accepted.
10. Bidders are advised to submit their bids in accordance with the BFAR BAC procedure for online bidding as well as for the printed copies as provided under ITB Clause 10 and Clause 11.

After the opening and evaluation of bids, the BAC, its staff and personnel, Secretariat and Technical Working Group (TWG), as well as Observers are prohibited from making or accepting any communication with any bidder

regarding the evaluation of their bids until issuance of Notice of Award (NOA). However, the BAC, through its Secretariat, may ask in writing the bidder for clarification of its request in writing. All responses to requests for clarification shall be in writing.

The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
