## INVITATION TO BID FOR:

# **Bid Ref no. NP 2021-04-A (Two Failed Bidding) “SUPPLY AND DELIVERY OF ICT COMPUTER HARDWARE FOR BFAR OFFICE PRODUCTIVITY PROJECT”**

1. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), through the General Appropriations Act for 2021 intends to apply the sums of **Eight Million Two Hundred Fifty-two Thousand Pesos Only (Php 8,252,000.00)** being the ABC to payments under the contract for **Bid Ref No. NP 2021-04-A (Two Failed Bidding)** entitled “**SUPPLY AND DELIVERY OF ICT COMPUTER HARDWARE FOR BFAR OFFICE PRODUCTIVITY PROJECT**”.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), now invites bids for the above Procurement Project. Delivery of the Goods is required within the period stated in the Section VI - Schedule of Requirements. Bidders should have completed, within Five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information the BFAR BAC Secretariat through electronic mailing address given below, and inspect of the Bidding Documents at [www.bfar.da.gov.ph](http://www.bfar.da.gov.ph).
5. A complete set of Bidding Documents may be acquired by interested Bidders at **2<sup>nd</sup> Floor – BAC Office, Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City** and/or through electronic means and upon payment of a non-refundable fee for the Bidding Documents in the amount stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by in person, or through electronic means.
6. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), will hold a Pre-Bid Conference<sup>1</sup> through video conference call using “Zoom” application on **November 23, 2021 (Tuesday), 11:00 A.M.** which shall be open to prospective bidders who have successfully completed registration one (1) calendar day prior to the Pre-bid Conference using Google Form [https://docs.google.com/forms/d/e/1FAIpQLSculZ4qcO6wDbeizhODN5b9IE9PiITjhbdH80-fUosjzjInDg/viewform?usp=pp\\_url](https://docs.google.com/forms/d/e/1FAIpQLSculZ4qcO6wDbeizhODN5b9IE9PiITjhbdH80-fUosjzjInDg/viewform?usp=pp_url) and in accordance with the “Annex A, Bidder’s Kit – I”.
7. Bids must be duly received by the BAC Secretariat through Electronic submission in accordance with the BFAR BAC procedure for online bidding stated in “Annex A Bidder’s kit II to VI” simultaneously with the submission of the printed copies as indicated in the **BDS Clause 15**.  
  
The Bidder shall submit bids on or before **December 01, 2021 (Wednesday), 10:30 A.M.** at the **BFAR – BAC Office, 2<sup>nd</sup> Floor Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City**, and electronic documents through [bac.eps@bfar.da.gov.ph](mailto:bac.eps@bfar.da.gov.ph).
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on **December 01, 2021 (Wednesday), 11:00 A.M.** through video conference call via “Zoom” application. Bids will be opened in accordance with the BFAR BAC procedure for online bidding as stated in the “Annex A, Bidder’s kit VII”. Late bids shall not be accepted.
10. Bidder are advised to submit their bids in accordance with the BFAR BAC procedure for online bidding as well as for the printed copies as provided under ITB Clause 10 and Clause 11.
