A RESOLUTION RECOMMENDING AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2021-16A (RE-BID) ENTITLED "SUPPLY AND DELIVERY OF VARIOUS PARTS FOR THE REPAIR AND MAINTENANCE OF DA-BFAR VESSELS" TO NAVNAUTICS PHILS. INC. (LOT 4) AND DYNAMIC POWER MARINE & INDUSTRIAL HARDWARE, INC. (LOT 6) FOR BEING THE SINGLE CALCULATED AND RESPONSIVE BIDDERS.

- WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of two (2) lots through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) and in the Bureau's website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;
- whereas, four (4) prospective bidders viewed the invitation posted at the PhilGEPS namely: (1) Buenafer Marine Spare Parts & Services (2) St. Christ International Trading, (3) Navnautics Phils. Inc. (4) Rope Systems Corporation and (5) ALS Marine Center Corporation;
- WHEREAS, on 11 August 2021, the Pre-Procurement Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2 /F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City;
- wherein two (2) bidders participated namely: (1) Navnautics Phils. Inc., and (2) St. Christ International Trading;
- WHEREAS, on 06 September 2021, the opening of bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City

wherein two (2) bidders submitted their bids, namely: Navnautics Phils. Inc. and Dynamic Power Marine & Industrial Hardware, Inc.;

whereas, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes submitted by the bidder/supplier were "PASSED" and declared eligible for the opening of the financial bid envelope;

**WHEREAS,** the financial bid envelopes submitted was opened and its bid offers is in the amount of the following:

whereas, after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared the Navnautics Phils. Inc. (Lot 4) and Dynamic Power Marine & Industrial Hardware, Inc. (Lot 6), offered the single bid as read for the said procurement project and will be subjected to post bidding evaluation and post qualification process to be conducted by the TWG;

whereas, in the detailed bid evaluation report submitted by the Technical Working Group (TWG), it was proposed that the below stated Bidders be declared as the Single Calculated and Responsive Bidder and therefore recommended to proceed in the conduct of Post Qualification procedure;

whereas, on 30 September 2021, the result of the post-qualification of compliance to the technical specification by Navnautics Phils. Inc. and Dynamic Power Marine & Industrial Hardware, Inc. for being the Single Calculated and Responsive Bidder (SCRB) for Lot 4 and Lot 6 respectively;

WHEREAS, the BAC, upon due consideration on the report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of contract to Navnautics Phils. Inc. (Lot 4) and Dynamic Power Marine & Industrial Hardware, Inc. (lot 6):

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with Bid Reference No. 2021-16A (Re-Bid) entitled "SUPPLY AND DELIVERY OF VARIOUS PARTS FOR THE REPAIR AND MAINTENANCE OF DA-BFAR VESSELS", be awarded to NAVNAUTICS PHILS. INC. (LOT 4) in the total amount of TWO MILLION TWO HUNDRED NINETY-TWO THOUSAND PESOS (₱ 2,292,000.00) and DYNAMIC POWER MARINE & INDUSTRIAL HARDWARE, INC. (LOT 6) in the total amount of TWO MILLION FOUR HUNDRED **THOUSAND PESOS** (# 2,400,000.00) for being the bidders who offered the Single Calculated and Responsive Bid for each Lot;

RESOLVED FINALLY that the Notice of Award be issued to the above stated bidders, for the preparation of the contract agreement, Notice to Proceed and commencement of the delivery of the Goods.
