



Contract Agreement Form for the Procurement of Goods (Revised)

THIS AGREEMENT made on this 15 day of DEC 15 2021 2021 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **1SYCAMORE FOOD VENTURES INC.** of 66B Bldg. Pascor Drive, Paranaque City (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, particularly for Bid Reference no. 2021-29 LOT 1 entitled "SUPPLY AND DELIVERY OF YEAR- END ANNUAL SUPPLIES (HAM) FOR THE BFAR EMPLOYEES" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SEVEN HUNDRED FIFTY-FIVE THOUSAND SEVEN HUNDRED ELEVEN PESOS ONLY (Php 755,711.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws
