A RESOLUTION RECOMMENDING AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2021-27 ENTITLED "SUPPLY AND DELIVERY OF SMALL POST HARVEST EQUIPMENT FOR DISTRIBUTION TO OPERATIONAL COMMUNITY FISH LANDING CENTERS (CFLC) IN REGIONS I, II, III AND CAR" TO INCA PHILIPPINES, INC. FOR BEING THE SINGLE CALCULATED AND RESPONSIVE BIDDER.

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of *one (1)* lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) and the Bureau's website (www.bfar.da.gov.ph) and conspicuous places within the Bureau's premises for *seven (7)* days;

WHEREAS, five (5) prospective bidders viewed the invitation posted at the PhilGEPS namely: (1) NSB Engineering Design and Fabrication, (2) RFMARU Industrial Design and Fabrication, (3) Double J Agri Supply (4) Inca Philippines, Inc. and (5) Adroit Construction;

WHEREAS, on *11 November 2021*, the Pre-Procurement Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2 /F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City;

WHEREAS, on *19 November 2021*, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein two (2) bidders participated namely: **(1) Inca Philippines, Inc. and (2) Double J Agri Supply;**

WHEREAS, on 01 December 2021, the Bids and Awards Committee conducted the opening of bids for the aforesaid procurement project at the BFAR BAC Room through videoconferencing via Zoom application. Two (2) interested bidders submitted their bid proposals in a sealed envelope containing its

Eligibility and Technical documents and the Financial bid proposal namely: **(1) Inca Philippines, Inc. and (2) Double J Agri Supply** and which was attended only by Inca Philippines, Inc.;

WHEREAS, during the preliminary evaluation using a non-discretionary pass or fail criteria, the Eligibility and Technical envelopes submitted by **Inca Philippines, Inc.** was "PASSED" and declared eligible for the opening of financial bid envelope while the Eligibility and Technical envelope of Double J Agri Supply were declared as non-responsive based on their submitted Warranty certificate which is incomplete. The Bid Document of the latter was ordered to be resealed and will be opened only if the BAC finds meritorious grounds in their motion for reconsideration, if any;

WHEREAS, the financial bid envelope submitted by **Inca Philippines, Inc.** was opened and its bid offer is in the amount of **Two Million Three Hundred Sixty-Two Thousand Five hundred pesos only (₱ 2,362,500.00)**;

WHEREAS, a Notice of Disqualification was sent to Double J Agri Supply dated 01 December 2021, a copy of which is attached as *Annex "A"*;

WHEREAS, on *06 December 2021*, Double J Agri Supply requested a reconsideration to lift the Disqualification and consider their bid offer a valid one, a copy of which is attached as *Annex "B"*;

WHEREAS, on *08 December 2021*, deliberation for the Motion for Reconsideration filed by Double J Agri Supply was conducted. The BAC Chairperson instructed the Technical Working Group to submit a report regarding their evaluation on the filed motion for reconsideration of Double J Agri Supply which is also attached as *Annex "C"*;

WHEREAS, on *13 December 2021*, a deliberation for the submitted Evaluation of the Technical Working Group on the motion for reconsideration filed by Double J Agri Supply was discussed and was unanimously agreed by the BAC to deny the said motion and set aside the TWG's evaluation;

WHEREAS, in the detailed bid evaluation report submitted by the Technical Working Group (TWG) last *14 December 2021*, it was proposed that the **Inca Philippines, Inc.** be declared as the Single Calculated and Responsive Bidder and therefore recommended to proceed in the conduct of Post Qualification procedure;

WHEREAS, on *20 December 2021*, the result of the post-qualification of compliance to the technical specification by **Inca Philippines, Inc.** for being the Single Calculated and Responsive Bidder (SCRB);

WHEREAS, the BAC, upon due consideration on the report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of the contract to **Inca Philippines, Inc.**;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with Bid Reference No. 2021-27 entitled "SUPPLY AND DELIVERY OF SMALL POST HARVEST EQUIPMENT FOR DISTRIBUTION TO OPERATIONAL COMMUNITY FISH LANDING CENTERS (CFLC) IN REGIONS I, II, III AND CAR", be awarded to **INCA PHILIPPINES, INC.** in the amount of **TWO MILLION THREE HUNDRED SIXTY-TWO THOUSAND FIVE HUNDRED PESOS (₱ 2,362,500.00)** for being the bidders who offered the *Single Calculated and Responsive Bid*;

RESOLVED FINALLY that the Notice of Award be issued to above-stated bidders, for the preparation of the contract agreement, Notice to Proceed and commencement of the delivery of the Goods.


