RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. BID 2021-34, ENTITLED "HIRING OF DA-BFAR SECURITY SERVICES FOR THE PERIOD OF JANUARY 2022- DECEMBER 31, 2022" TO STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC. AS THE BIDDER WHO OFFERED THE LOWEST CALCULATED AND RESPONSIVE BID

WHEREAS, Purchase Request No. **21-11-826** pertains to the Hiring of Security Services for the Period of January 01- December 31, 2022 for the Bureau of Fisheries and Aquatic Resources (BFAR) with an Approved Budget for the Contract amounting to Php 32,293,944.00;

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Bureau's website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;

WHEREAS, on December 15, 2021 (Wednesday) at 10:00 am, the Pre-bid Conference was conducted by the Bids and Awards Committee (BAC) at the BAC Conference Room 2/F Fisheries Building Complex BPI Compound Brgy. Vasra, Visayas Ave., Q.C.;

WHEREAS, the opening of bids was conducted last January 11, 2022, 10:00 AM at the Legal Division Conference Room 2/F Fisheries Building Complex BPI Compound Brgy. Vasra, Visayas Ave., Q.C and was only participated by **Star Special Corporate Security Management, Inc.;**

WHEREAS, during the opening of the Eligibility and Technical Envelopes the abovementioned bidder "PASSED" the evaluation and was declared eligible for the opening of the financial envelopes;

WHEREAS, during the opening of the Financial Documents of the above-mentioned bidders, their respective bid proposals "As Read" are as follows:

WHEREAS, in the Post-Qualification Report submitted by the TWG dated January 28, 2022 the TWG recommended the award be given to **STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC.,** for being the Single Calculated and Responsive Bidder;

WHEREAS, a copy of the said report is hereby made an integral part of the Resolution;

WHEREAS, the BAC, upon due consideration on the Report of the TWG, resolved to adopt the same and recommend the awarding of contract to **STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC.** for being the Lowest Calculated and Responsive Bidder;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement project entitled "HIRING OF DA-BFAR SECURITY SERVICES FOR THE PERIOD OF JANUARY 2022- DECEMBER 31, 2022" is recommended to be awarded to STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC. for being the Lowest Calculated & Responsive Bid in the amount of THIRTY-ONE MILLION TWO HUNDRED FORTY-THREE THOUSAND ONE HUNDRED SEVENTY-THREE AND 48/100 (Php 31,243,173.48) ONLY.
