





THIS AGREEMENT made on this DEC 15 2021 2021 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **CRESTO TRADING CORP.** of 61, J. Chanyungco Street, Corner Eagle Street, New Marikina Subdivision, Marikina, 1801 Metro Manila (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, particularly for Bid Reference no. 2021-29 LOT 2 entitled "SUPPLY AND DELIVERY OF YEAR-END ANNUAL SUPPLIES (RICE) FOR THE BFAR EMPLOYEES" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION FOUR HUNDRED SIXTY THOUSAND SEVEN HUNDRED THIRTY PESOS ONLY (Php 1,460,730.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws
