Contract Agreement Form for the Procurement of Goods (Revised)

THIS AGREEMENT made on this _____ day of _____ 2021 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **A.COSTA ENTERPRISES** of 200 Rizal St, Legazpi Port District, Legazpi City Albay (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, particularly for **Bid Reference no. 2021-24** entitled "**SUPPLY AND DELIVERY OF COOLERS FOR OFFICIAL USE IN THE IMPLEMENTATION OF KADIWA OPLAN ISDA IN NATIONAL CAPITAL REGION**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SIX MILLION EIGHTY-FOUR THOUSAND PESOS ONLY (6,084,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws
