CONTRACT AGREEMENT FOR INFRASTRUCTURE PROJECT

THIS AGREEMENT, made this _____ day of ______, 2021 between BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) of Fisheries Bldg., Complex, Bureau of Plant Industry Compound, Visayas Avenue, Diliman, Quezon City of the Philippines (hereinafter called the "Entity") and PANABO GENERAL CONTRACTOR & DEVELOPMENT CORPORATION of Blk. 1 Lot 26 Sinahon Bldg., Prk. Alakta New Pandan National Highway, Panabo City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute Bid Reference No. 2021-28 entitled "ESTABLISHMENT OF ALT BANGUS HATCHERY AT BFAR-NMC RECLAMATION AREA OF 5,000 SQM. AT COASTAL ROAD, BARANGAY CAGANGOHAN, PANABO CITY, DAVAO DEL NORTE." (hereinafter called "the Works") and the Entity has accepted the Bid for Three Million Three Hundred Forty-Eight Thousand Nine Hundred Ninety-Nine Pesos and Ninety Nine Centavos only (Php 3,348,999.99) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
