A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT OF BID REFERENCE NO. 2021-28 ENTITLED "ESTABLISHMENT OF ALT BANGUS HATCHERY AT BFAR-NMC RECLAMATION AREA OF 5,000 SQM. AT COASTAL ROAD, BARANGAY CAGANGOHAN, PANABO CITY, DAVAO DEL NORTE" TO PANABO GENERAL CONTRACTOR & DEVELOPMENT CORPORATION, FOR BEING THE LOWEST CALCULATED AND RESPONSIVE BIDDER.

WHEREAS, the BFAR bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the bidding of the above-mentioned procurement project consisting of one (1) lot through posting in the Philippines Government electronic Procurement System (PhilGEPS), the Bureau's website (www.bfar.da.gov.ph), and in conspicuous places for seven (7) days;

WHEREAS, the project entitled "ESTABLISHMENT OF ALT BANGUS HATCHERY AT BFAR-NMC RECLAMATION AREA OF 5,000 SQM. AT COASTAL ROAD, BARANGAY CAGANGOHAN, PANABO CITY, DAVAO DEL NORTE." with an approved budget for the contract of Four Million Pesos (PhP 4,000,000.00);

WHEREAS, on the 11<sup>th</sup> day of November, 2021 at 10:30 am, the Pre-Procurement Conference for the above-mentioned procurement project was conducted via videoconference through Zoom application;

WHEREAS, on the 23<sup>rd</sup> day of November, 2021 at 9:00 am, the Pre-bid Conference for the above-mentioned procurement project was conducted via videoconference through Zoom application, in which three (3) bidders/contractors participated, namely:

- 1. ALZAM ENT. INC.
- 2. Panabo General Contractor and Development
- 3. YPC Contractor

WHEREAS, on the 7<sup>th</sup> day of December, 2021 at 9:00 am, the opening of bids for the above-mentioned procurement project was conducted via videoconference through Zoom application, in which two (2) interested bidders/contractors participated and submitted their bidding documents, namely:

## 1. DCLabro3 Construction

## 2. Panabo General Contractor and Development

WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Eligibility and Technical envelopes submitted by bidders/contractors were "PASSED" and declared eligible for the opening of the financial bid envelopes;

**WHEREAS,** during the opening of the financial bid envelopes submitted by bidders/contractors, their bids were read and tabulated as follows:

WHEREAS, after reading and determining the amount of bids as proposed by the bidders/contractors, the BAC declared that "Panabo General Contractor and Development", offered the lowest bid as read for the said procurement project and will be subjected to post bidding evaluation and post qualification process to be conducted by the Technical Working Group (TWG);

WHEREAS, the opened bid envelopes were turned-over to the Technical Working Group (TWG) for detailed bid evaluation and post qualification;

WHEREAS, on December 10, 2021, the Technical Working Group (TWG) submitted the detailed bid evaluation report and it was proposed that "Panabo General Contractor and Development", be declared as the Lowest Bidder and therefore recommended to proceed in the conduct of Post-qualification procedure;

whereas, on December 10, 2021, the BFAR-BAC issued the notice of postqualification to "Panabo General Contractor and Development" and the latter submitted the requirements for evaluation of the Technical Working Group (TWG);

whereas, on December 15, 2021, the Technical Working Group (TWG) submitted a post-qualification report and it was proposed that the award for the said procurement project be given to "Panabo General Contractor and Development", as the Bidder who offered the Lowest Calculated and Responsive Bidder, a copy of the said Report/Memorandum is hereby made as integral part of this Resolution;

WHEREAS, the BAC, upon due consideration on the Report of the TWG, resolved to adopt the same and recommend the awarding of contract to "Panabo General Contractor and Development", for being the Lowest Calculated and Responsive Bidder; NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement project entitled "ESTABLISHMENT OF ALT BANGUS HATCHERY AT BFAR-NMC RECLAMATION AREA OF 5,000 SQM. AT COASTAL ROAD, BARANGAY CAGANGOHAN, PANABO CITY, DAVAO DEL NORTE." is recommended to be awarded to PANABO GENERAL CONTRACTOR & DEVELOPMENT CORPORATION, for being the LOWEST CALCULATED & RESPONSIVE BID in the amount of Three Million Three Hundred Forty-Eight Thousand Nine Hundred Ninety-Nine Pesos and Ninety Nine Centavos only (Php 3,348,999.99).

**RESOLVED FINALLY** that, the Notice of Award be issued to "Panabo General Contractor and Development", for the preparation of the Contract Agreement, Notice to Proceed and commencement to the project.
