**Remarks/Market Observations:**

**The following observations were gathered from market personnel:**

- In general, minimal but still sufficient volumes of fresh marine commodities were unloaded at Navotas Fish Port this week. Among the fishery commodities recorded were dalagang bukid, pusit, espada, lumut,tunsoy, tamban, and others. Consequently, for medium-sized local-fresh galunggong (*Decapterus macrosoma*), minimal unloading of the said commodity was observed this week at prevailing wholesale price of Php120.00/kg sourced from Visayan Sea. Additionally, other local-fresh variants (i.e., balsa, burot, babae) were noted at the fish port this week sourced from Northern Palawan and Batangas.
- Similarly, lesser unloadings of imported-frozen galunggong lakali (*Decapterus macrosoma*) was observed at the Fish Port this week. In fact, only two (2) brokers have display of medium-sized commodity on 9 May 2022 with an actual wholesale price of Php120.00/kg sourced from China and Vietnam.
- Meanwhile, there remains to be no unloadings of medium-sized alumahan was recorded at Navotas Fish Port this week.
- For medium-sized bangus, still ample supplies were observed throughout the week. However, majority of the supplies are large sizes sourced from Pangasinan and Bulacan.
- Lastly, the prevailing wholesale price of tilapia (Batangas) were stabilized at Php90.00/kg this week as the supply for the said commodity continued to be adequate.
- Top fishery commodities in the monitored markets are sourced mainly from the following areas:
  - Bangus - Pangasinan, Bulacan
  - Tilapia - Batangas
  - Local Galunggong- Visayan Sea
  - Alumahan- NA
  - Imported galunggong - China and Vietnam
- Precautionary measures (e.g., wearing of face mask and face shields as well as white boots and shirts, mandatory temperature checks, and regularly scheduled cleaning and disinfection) were continuously implemented by the Philippine Fisheries Development Authority (PFDA) at Navotas Fish Port Complex to safeguard vendors and buyers against COVID-19.

*Note: Wholesale price data is as of May 2 & 10, 2022, as price data from PFDA was not provided within the internal cut off of the covering period of this report.*

(\*\*) - Actual Price - price data collected did not reach the minimum requirement of three (3) samples per commodity per market. This could be due to limited volumes or no available supplies at the time of monitoring.
