CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made the ___ day of APR 22 2022 2022 between **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **ALL CERTIFIED EQUIPMENT TRADING CORPORATION** of 905 Phil-AM EDSA, Quezon City, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for **BID REFERENCE NO. 2022 - 08** entitled "**SUPPLY, DELIVERY AND INSTALLATION OF DIESEL MARINE GENERATOR SET WITH FAST MOVING PARTS FOR DA - BFAR MCS 3007 PATROL VESSEL**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SIX MILLION THREE HUNDRED NINETY - SEVEN THOUSAND PESOS ONLY (PhP6,397,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto;

In consideration for the sum of **SIX MILLION THREE HUNDRED NINETY – SEVEN THOUSAND PESOS ONLY (Php6,397,000.00)** or such other sums as may be ascertained, **ALL CERTIFIED EQUIPMENT TRADING CORPORATION** agrees to **BID REFERENCE NO. 2022 – 08** entitled **“SUPPLY, DELIVERY AND INSTALLATION OF DIESEL MARINE GENERATOR SET WITH FAST MOVING PARTS FOR DA – BFAR MCS 3007 PATROL VESSEL”** in accordance with his/her/its Bid.
- 4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
