A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT OF BID REFERENCE NO. 2022 – 08 ENTITLED “SUPPLY, DELIVERY AND INSTALLATION OF DIESEL MARINE GENERATOR SET WITH FAST MOVING PARTS FOR DA – BFAR MCS 3007 PATROL VESSEL”.

WHEREAS, the Bureau of Fisheries and Aquatic Resources – Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the procurement project entitled “**SUPPLY, DELIVERY AND INSTALLATION OF DIESEL MARINE GENERATOR SET WITH FAST MOVING PARTS FOR DA – BFAR MCS 3007 PATROL VESSEL**” (herein referred to as “Procurement Project”) consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS), in the Bureau’s website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau’s premises for seven (7) days;

WHEREAS, on 9th day of March 2022 at 11:00 AM the Pre-Bid Conference for the Procurement Project was held through video-conferencing or webcasting via “Zoom” application;

WHEREAS, there were three (3) bidders attended in the said Pre-Bid conference:

1. **FIL POWER GROUP AND MARKETING CORPORATION;**
2. **ALL CERTIFIED EQUIPMENT TRADING CORPORATION;** and
3. **PROPMECH CORPORATION**

WHEREAS, on 21st day of March 2022 at 11:00 AM, the opening of bids for the Procurement Project was held through video-conferencing or webcasting via “Zoom” application;

WHEREAS, in the said Bid Opening, only one (1) bidder submitted a bid envelope namely, **All Certified Equipment Trading Corporation;**

WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes, the above-

mentioned bidder were "PASSED" and declared eligible for the opening of the financial bid envelope;

WHEREAS, during the opening of the financial bid envelope submitted by the bidder, its bid were read and tabulated as follows:

WHEREAS, after reading and determining the amount of bid as proposed by the qualified bidder, the BAC declared the offer of **All Certified Equipment Trading Corporation** as Single bid as read, the said procurement project will be subjected to post bidding evaluation and post qualification process to be conducted by the Technical Working Group (TWG);

WHEREAS, the BAC ordered the BAC Secretariat to forward the copies of the Eligibility, Technical and Financial envelopes of the bidder to the TWG for detailed evaluation and post-qualification process;

WHEREAS, the TWG submitted the bid evaluation report stating *inter alia* their recommendation for the conduct of the post-qualification process on the offer of **All Certified Equipment Trading Corporation**;

WHEREAS, the post qualification documents submitted by the Single Calculated and Responsive Bidder were transmitted to the TWG;

WHEREAS, the TWG recommended in the post qualification report to award the Procurement Project to **All Certified Equipment Trading Corporation** for being the Single Calculated and Responsive Bidder;

WHEREAS, the BAC, after due consideration on the report of the TWG, resolved to adopt the same and recommend the awarding of contract to **All Certified Equipment Trading Corporation**;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the Committee hereby recommends that the procurement of the project with **Bid Reference No. 2022-08** entitled "**SUPPLY, DELIVERY AND INSTALLATION OF DIESEL MARINE GENERATOR SET WITH FAST MOVING PARTS FOR DA - BFAR MCS 3007 PATROL VESSEL**", be awarded to **ALL CERTIFIED EQUIPMENT TRADING CORPORATION**, for being the bidder who offered the Single Calculated and Responsive Bid in the total amount of **SIX MILLION THREE HUNDRED NINETY - SEVEN THOUSAND PESOS ONLY (PhP 6,397,000.00)** and the Notice of Award be issued to **ALL CERTIFIED EQUIPMENT**

TRADING CORPORATION, for the preparation of the contract agreement, Notice to Proceed and commencement of the delivery of the Goods;
