Contract Agreement Form for the Procurement of Goods (Revised)

THIS AGREEMENT made on this 04 day of APR 2022 2022 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **THERMAX POWER & ENERGY SUPPLIES AND EQUIPMENT, INC** of **B5 L2 BRGY. SAN GABRIEL AREA K, General Mariano Alvarez, Cavite** (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, particularly for Bid Reference no. **2022-02** entitled "**SUPPLY AND DELIVERY OF DIGITAL OIL PRECISION TESTER FOR 14 UNITS OF MCS PATROL VESSELS, 2 UNITS OF MMOV, TAMBAKOL AND DYCA**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SIXTEEN MILLION FIFTY-SEVEN THOUSAND FIVE HUNDRED PESOS ONLY (Php 16,057,500.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conformer thereto; and
- v. Other contract documents that may be required by existing law

4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


