A RESOLUTION DECLARING A FAILURE OF BIDDING FOR BID REFERENCE NO. 2022-16 ENTITLED: "SUPPLY OF MATERIALS AND LABOR FOR DRY DOCKING AND REPAIR OF DA-BFAR MCS PATROL VESSELS".

whereas, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of two (2) lots through posting in the Philippine Government Electronic Procurement Service (PhilGEPS), and in Bureau's website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises from April 27, 2022 To May 16, 2022;

WHEREAS, on May 4, 2022 at 9:00 a.m. the Pre-Bid Conference for the abovementioned procurement project was conducted through video conferencing via Zoom application wherein one (1) bidder/supplier attended, Mr. James Carl David of Josefa Slipways Inc.

WHEREAS, on May 16, 2022 at 9:00 a.m. the opening of bids for the above-mentioned procurement project was not conducted due to no bids were received.

WHEREAS, Section 35. 1 of the IRR of RA 9184 states that:

35.1. The BAC shall declare the bidding a failure when:

- a) No bids are received;
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of consulting services, there is no successful negotiation; or
- d) The bidder with the LCRB, HRRB, SCRB or SRRB refuses, without justifiable cause, to accept the award of contract, and no award is made in accordance with Section 40 of the Act and this IRR.
