**WHEREAS,** the opening of bids was conducted last May 23, 2022 (Monday), 1:30 pm at the BAC Office, 2<sup>nd</sup> Flr Fisheries Building Complex Brgy. Vasra, Visayas Ave., Quezon City and through video-conferencing via “Zoom” application, which was participated by the lone bidder namely, **AXZEEN SECURITY AGENCY;**

**WHEREAS,** during the opening of the Eligibility and Technical Envelopes the above-mentioned bidder “PASSED” the evaluation and was declared eligible for the opening of the financial envelopes;

**WHEREAS,** during the opening of the Financial Documents of the above-mentioned bidders, their respective bid proposals “As Read” are as follows:

**WHEREAS,** in the Post-Qualification Report submitted by the TWG dated May 27, 2022 the TWG recommended the award be given to **AXZEEN SECURITY AGENCY** for being the Single Calculated and Responsive Bidder;

**WHEREAS,** a copy of the said report is hereby made an integral part of the Resolution;

**WHEREAS,** the BAC, upon due consideration on the Report of the TWG, resolved to adopt the same and recommend the awarding of contract to **AXZEEN SECURITY AGENCY** for being the Single Calculated and Responsive Bidder;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement project under Bid Reference No. 2022-15 entitled “Hiring of Security Services for the Period of May 2022 to December 31, 2022 at the BFAR- National Mariculture Center” is recommended to be awarded to AXZEEN SECURITY AGENCY being the Single Calculated & Responsive Bid in the amount of THREE MILLION SIX**

**HUNDRED SIXTEEN THOUSAND ONE HUNDRED SIXTEEN PESOS AND 56/100 (Php 3,616,116.56) ONLY.**
