Remarks/Market Observations:

The following observations were gathered from market personnel:

- Overall, minimal but sufficient volumes of fresh marine commodities were unloaded at Navotas Fish Port (wholesale) this week. Other fishery commodities recorded were gulyasan, pusit, dalagang bukid, lumot, betilya, lapad, batalay, balsa, galunggong, and burot.
- More specifically, for medium-sized local-fresh galunggong lakai (*Decapterus macrosoma*), a total of five (5) brokers unloaded last July 11 & 12 at Navotas Fish Port. The low supply resulted to a prevailing wholesale price of Php190.00/kg this week. Majority of the supplies unloaded were derived from Palawan. There are also other local galunggong variants available like balsa (*Decapterus macarellus*), babae (*Decapterus russelli*), and burot (*Decapterus kurroides*).
- There is an increased in the prevailing wholesale price of imported-frozen galunggong this week due to the minimal supply of local-fresh galunggong. The higher demand for imported-frozen galunggong also contributed to the increased in price.
- The prevailing wholesale prices of bangus and tilapia remained stable this week due to the sufficient supply and stable demand at the said fish port. The small price increment may vary depending on the size, source area, and quality (freshness).
- Top fishery commodities in the monitored markets are sourced mainly from the following areas:
 - Bangus - Pangasinan, Bulacan, Laguna
 - Tilapia - Batangas
 - Local galunggong- Northern Palawan
 - Imported galunggong - China, Vietnam
- Market administrators continue to strictly implement precautionary safety measures in the monitored markets to ensure the consumers and vendors safety and avoid the further spread of highly infectious COVID-19 OMICRON variant in accordance with the General Community Quarantine- Alert Level 1 guidelines. Among these measures are the mandatory wearing of face masks, social distancing and regular schedule of cleaning and disinfection in the markets, and among others.

Note: Wholesale price data is as of June 11 & 12, 2022, as price data from PFDA was not provided within the internal cut off of the covering period of this report.

(*) - Actual Price - price data collected did not reach the minimum requirement of three (3) samples per commodity per market. This could be due to limited volumes or no available supplies at the time of monitoring.
