CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made the 29 day of JUN 29 2022 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of Fisheries Bldg., Complex, Bureau of Plant Industry Compound, Visayas Avenue, Diliman, Quezon City of the Philippines (hereinafter called "the Entity") of the one part and **MULTI-FOLD LINKS, INC.**, Platinum 2000, Annapolis Street, Greenhills, San Juan, Metro Manila. (hereinafter called "the Supplier") of the other part:


WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Bid Reference no. 2022-10-A (Re-bidding)** project entitled "**ONE (1) YEAR COMPREHENSIVE MAINTENANCE AND SUPPORT SERVICES FOR THE IT INFRASTRUCTURE AND AUXILIARY EQUIPMENT OF THE BFAR.**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SIXTEEN MILLION SIX HUNDRED NINETY-SIX THOUSAND EIGHTEEN PESOS ONLY (16,696,018.00)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;




