CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made the 23 day of JUN 2022 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of Fisheries Bldg., Complex, Bureau of Plant Industry Compound, Visayas Avenue, Diliman, Quezon City of the Philippines (hereinafter called "the Entity") of the one part and **INCA PHILIPPINES, INC.**, Building 4 Philcrest Compound, Km. 23, West Service Rd. Bo. Cupang, Muntinlupa City (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Bid Reference no. 2022-19 (LOT 2)** project entitled "**SUPPLY, DELIVERY, AND INSTALLATION OF TWO (2) HDPE CAGES FOR THE TECHNO-DEMO ON BANGUS PRODUCTION IN MARINE FISH CAGES OF BFAR-NATIONAL MARICULTURE CENTER (NMC) PANABO, DAVAO DEL NORTE.**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION FOUR HUNDRED NINETY-SIX THOUSAND PESOS ONLY (P1,496,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
- Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;




