CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made on this 11 day of 12 2022 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **NAVNAUTICS PHILS., INC.** 198 Unit C East, C-3 Road 5th Avenue Grace Park Caloocan City (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **2022-23 entitled SUPPLY AND DELIVERY OF MARINE SAFETY, COMMUNICATION, AND NAVIGATIONAL AIDS FOR THE 4 UNITS STEEL-HULLED 21 METER RINGNET VESSELS** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION THREE HUNDRED TWENTY-ONE THOUSAND SIX HUNDRED FOUR PESOS (Php 1,321,604.00) ONLY** (hereinafter called "the Contract Price").

 - vi. Contract
 - vii. Notice to Proceed
 - viii. Performance Security;
 - ii. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **ONE MILLION THREE HUNDRED TWENTY-ONE THOUSAND SIX HUNDRED FOUR PESOS (Php 1,321,604.00) ONLY** or such other sums as may be ascertained **NAVNAUTICS PHILS., INC** agrees to the project **SUPPLY AND DELIVERY OF MARINE SAFETY,**




