"REPAIR AND REHABILITATION OF ASIAN FISHERIES ACADEMY (AFA) AT BFAR –NFDC BINLOC, DAGUPAN"

 The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), through the General Appropriations Act for 2022 intends to apply the sum of One Million Two Hundred Fifty Thousand Pesos (PhP 1,250,000.00) being the Approved Budget for the Contract (ABC) to payment under the contract for Bid Reference No. 2022 – 35 entitled "REPAIR AND REHABILITATION OF ASIAN FISHERIES ACADEMY (AFA) AT BFAR – NFDC BINLOC, DAGUPAN". Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The DA BFAR now invites bids for the above Procurement Project. Completion of the Works is required within *thirty (30) calendar days* upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- **3.** Bidding will be conducted through open competitive bidding procedures using non-discretionary *"pass/fail"* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

- **4.** Interested bidders may obtain further information from *DA BFAR Bids and Awards Committee (BAC) Secretariat* and inspect the Bidding Documents at the address given below from *8:00 AM to 5:00 PM, Monday to Friday*.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *July 29, 2022* to *August 16, 2022* from *8:00 AM* to *5:00 PM, Monday to Friday and up to 10:30 AM of August 17, 2022* at the given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, or through electronic means.
- 6. The DA BFAR will hold a Pre-Bid Conference¹ on *August 5, 2022, Friday at 11:00 AM* through videoconferencing/webcasting via "Zoom" application, which shall be open to prospective bidders who have successfully completed registration one (1) calendar day prior to the Pre-bid Conference using Google Form https://docs.google.com/forms/d/e/1FAIpQLSe2AXEE3YCCFUsrLDPL7-K2w6Ic4Qxq83oP7NhMllgDkEar5g/viewform?usp=pp_url and in accordance with the "Annex A, Bidder's Kit I".
- Bids must be duly received by the BAC Secretariat through, the options given below and as indicated in ITB Clause 15 of this bidding documents, on or before August 17, 2022, Wednesday at 10:30 AM. Late bids shall not be accepted:
 - (i) manual submission at the office address : 2/F BAC Office, Fisheries Building Complex, BPI Compound, Visayas Avenue, Diliman, Quezon City; or
 - (ii) Both *manual and online or electronic submission* at <u>bac.eps@bfar.da.gov.ph</u> through BFAR BAC Online Bidding Procedure.
- **8.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- **9.** Bid opening shall be on *August 17, 2022, Wednesday* at *11:00 AM* through video conferencing or webcasting via *"Zoom"* application. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity and in accordance with the BFAR BAC procedure for online bidding as stated in the *"Annex A, Bidder's kit VII"*.
- **10.** The DA BFAR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.
