**Remarks/Market Observations:**

**The following observations were gathered from market personnel:**

- At Navotas Fish Port (wholesale), ample volumes of fresh marine commodities were unloaded this week. Among the fishery commodities recorded were tambakol, gulyasan, pusit, lumot, dalagang bukid, lapad, betilya, matangbaka, batalay, tunsoy, salinyase, and others.
- For local-fresh galunggong lalaki (*Decapterus macrosoma*), limited supply were observed at the Navotas Fish Port this week. This resulted to a high prevailing wholesale price of Php183-190/kg. Adequate volumes of small-sized commodity of other local gg variant like burot (*Decapterus kurroides*), balsa (*Decapterus macarellus*), babae (*Decapterus russelli*) were unloaded at the fish port this week. Majority of the supplies were derived from Zambales, Batangas and Palawan.
- More supplies of imported-frozen galunggong (lalaki) were observed due to no available supply of local-fresh galunggong last 29 July. This resulted to a Php20.00/kg decreased in the prevailing price of the said commodity. Some of the vendors prefer selling imported galunggong due to its cheaper price making it easier to sell.
- For aquaculture commodities like bangus and tilapia, the prevailing wholesale prices remained stable due to the sufficient supply and stable demand this week. Price may differ depending on source area, quality and size.
- Top fishery commodities in the monitored markets are sourced mainly from the following areas:
  - Bangus - Pangasinan, Bulacan, Laguna
  - Tilapia - Batangas
  - Local galunggong- Northern Palawan
  - Imported galunggong - China, Vietnam
- Market administrators continue to strictly implement precautionary safety measures in the monitored markets to ensure the consumers and vendors safety and avoid the further spread of highly infectious COVID-19 OMICRON variant in accordance with the General Community Quarantine- Alert Level 1 guidelines. Among these measures are the mandatory wearing of face masks, social distancing and regular schedule of cleaning and disinfection in the markets, and among others.

*Note: Wholesale price data is as of July 19 & 23, 2022, as price data from PFDA was not provided within the internal cut off of the covering period of this report.*

(\*) - Actual Price - price data collected did not reach the minimum requirement of three (3) samples per commodity per market. This could be due to limited volumes or no available supplies at the time of monitoring.
