CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made on this ____ day of _____ 2022 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **A.COSTA ENTERPRISES** of #200 RIZAL STREET BRGY. TINAGO, LEGAZPI CITY (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **2022-25 entitled "SUPPLY, DELIVERY AND INSTALLATION OF FABRICATED FRAMED CANVASS, HYDRO PLOTS AND ACCESSORIES FOR AQUAPONICS SYSTEM"** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION ONE HUNDRED SEVENTEEN THOUSAND PESOS AND FIVE CENTAVOS (Php 1,117,000.05)** (hereinafter called "the Contract Price").

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
