 - vii. Notice to Proceed
 - viii. Performance Security;
 - ii. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of ONE MILLION ONE HUNDRED SEVENTEEN THOUSAND PESOS AND FIVE CENTAVOS (Php 1,117,000.05) or such other sums as may be ascertained, A.COSTA ENTERPRISES agrees to the project 2022-25 entitled "SUPPLY, DELIVERY AND INSTALLATION OF FABRICATED FRAMED CANVASS, HYDRO PLOTS AND ACCESSORIES FOR AQUAPONICS SYSTEM" in accordance with his/her/its Bid.
