**CONTRACT AGREEMENT FOR GOODS & SERVICES**

THIS AGREEMENT made on this \_\_\_\_ day of \_\_\_\_\_ 2022 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **APEX Office Supplies and Equipment Trading 202 Tara Residences, Culiat Q.C.** (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **2022-29** entitled "**SUPPLY AND DELIVERY OF ICT EQUIPMENT (LAPTOP AND PRINTER)**" Lot no. 1 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO MILLION SIXTEEN THOUSAND PESOS (Php 2,016,000.00) ONLY** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

    - viii. Performance Security;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**


