**Remarks/Market Observations:**

**The following observations were gathered from market personnel:**

- In general, sufficient volumes of fresh marine commodities were still unloaded at Navotas Fish Port (wholesale) this week. Fishery commodities like tambakol, gulyasan, tulingan, matambaka, dalagang bukid, lapad, pusit, tamban, and others were recorded this week.
- For local-fresh galunggong (*Decapterus macrosoma*), only 1 broker unloaded last 31 August at an actual wholesale price of Php180.00/kg sourced from Palawan. However, no supply was unloaded last 2 September due to the rainy weather condition brought by the effects of Typhoon "henry". Majority of the supplies available were galunggong variants (i.e., balsa, babae) sourced from Batangas and Zambales.
- Imported-frozen galunggong remained available at the Navotas Fish Port this week. The prevailing wholesale price was sustained at Php130.00/kg. This is an alternate commodity for local-fresh galunggong.
- There is an available supply of Alumahan noted at the Navotas Fish Port this week. The supply still remains unpredicted where the supply was only available on 2 September this week. An actual wholesale of Php140.00/kg was recorded sourced at Bicol.
- The prevailing wholesale price of bangus and tilapia have remained stable due to the sufficient supply and stable demand at the fish port. Prices vary depending on source area, quality, and sizes.
- Top fishery commodities in the monitored markets are sourced mainly from the following areas:
  - Bangus - Pangasinan, Bulacan, Laguna
  - Tilapia - Batangas
  - Local galunggong - Palawan
  - Imported galunggong - China, Vietnam
- Market administrators continue to strictly implement precautionary safety measures in the monitored markets to ensure the consumers and vendors safety and avoid the further spread of highly infectious COVID-19 OMICRON variant in accordance with the General Community Quarantine- Alert Level 1 guidelines. Among these measures are the mandatory wearing of face masks, social distancing and regular schedule of cleaning and disinfection in the markets, and among others.

*Note: Wholesale price data is as of August 27 & 29, 2022, as price data from PFDA was not provided within the internal cut off of the covering period of this report.*

(\*) - Actual Price - price data collected did not reach the minimum requirement of three (3) samples per commodity per market. This could be due to limited volumes or no available supplies at the time of monitoring.
