## CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made the 29<sup>th</sup> day of SEPTEMBER, 2022 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of Fisheries Bldg., Complex, Bureau of Plant Industry Compound, Visayas Avenue, Diliman, Quezon City of the Philippines (hereinafter called "the Entity") of the one part and **FIVE GGM MARKETING** Blk 9, Lot 4 Talisay St., Awhag, Bacaca, Davao City. (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Bid Reference no. 2022-36** project entitled "**SUPPLY, DELIVERY, AND INSTALLATION OF SIX (6) ANAHAW CAGES FOR THE TECHNO-DEMO OF BANGUS AND HIGH VALUE SPECIES (HVS) PRODUCTION IN MARINE FISH CAGES OF BFAR-NATIONAL MARICULTURE CENTER (NMC) PANABO, DAVAO DEL NORTE.**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION FIVE HUNDRED FIVE THOUSAND FOUR HUNDRED PESOS ONLY (P 1,505,400.00)** (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

In consideration for the sum of **ONE MILLION FIVE HUNDRED FIVE THOUSAND FOUR HUNDRED PESOS ONLY (P 1,505,400.00)** or such other sums as may be ascertained, **FIVE GGM MARKETING**, agrees to **Bid Reference no. 2022-36** project entitled **"SUPPLY, DELIVERY, AND INSTALLATION OF SIX (6) ANAHAW CAGES FOR THE TECHNO-DEMO OF BANGUS AND HIGH VALUE SPECIES (HVS) PRODUCTION IN MARINE FISH CAGES OF BFAR-NATIONAL MARICULTURE CENTER (NMC) PANABO, DAVAO DEL NORTE."** in accordance with his/her/its Bid.


