The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), through the General Appropriations Act for 2022 intends to apply the sum of **Two Million Pesos (₱2,000,000.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for **Bid Reference No. 2022-46** entitled **“INSTALLATION OF SOLAR (PV MODULE HYBRID SYSTEM) WATER PUMPS (SHALLOW/DEEP WELL) AND OTHER STRUCTURES AT BFAR NATIONAL FRESHWATER FISHERIES TECHNOLOGY CENTER (NFFTC)”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The DA – BFAR now invites bids for the above Procurement Project. Completion of the Works is required within **sixty-five (65) calendar days** upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary *“pass/fail”* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from **DA – BFAR Bids and Awards Committee (BAC) Secretariat** and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM, Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested bidders at **2/F, BAC Office, Fisheries Building Complex, BPI Compound, Brgy. Vrasa, Visayas Ave., Quezon City** and/or through **electronic means** and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above. The DA-BFAR shall allow the bidder to present its proof of payment for the fees in person, or through electronic means.

9. Bid opening shall be through video conferencing or webcasting via **“Zoom”** application. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity and in accordance with the BFAR – BAC procedure for online bidding as stated in the **“Annex A, Bidder’s kit VII”**.

The DA – BFAR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
