**BFAR MAIN BUILDING ANCILLARY SYSTEM
MODERNIZATION**

1. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), through the 2022 General Appropriations Act intends to apply the sum of **FORTY-ONE MILLION FOUR HUNDRED FIFTY-FOUR THOUSAND THREE HUNDRED SIXTY-TWO AND 68/100 (Php 41,454,362.68)** being the ABC to payment under the contract for **Bid Reference No. 2022-52** entitled **"BFAR MAIN BUILDING ANCILLARY SYSTEM MODERNIZATION"**.
2. Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. The DA-BFAR now invites bids for the above Procurement Project. Completion of the Works is required within **TWO HUNDRED FORTY (240)** calendar days upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary *"pass/fail"* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to

Filipino citizens, pursuant to RA No. 5183.

5. Prospective Bidders may obtain further information from the BFAR BAC Secretariat through electronic mailing address given below, and inspect of the Bidding Documents at www.bfar.da.gov.ph.
6. A complete set of Bidding Documents may be acquired by interested Bidders at 2nd Floor – BAC Office, Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City and/or through electronic means and upon payment of a non-refundable fee for the Bidding Documents in the amount stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by in person, or through electronic means.
7. The DA-BFAR will hold a Pre-Bid Conference¹ through a video conference call using Zoom application on **September 16, 2022 (Friday) at 10:00 am** which shall be open to prospective bidders who have successfully completed registration one (1) calendar day prior to the pre-bid conference using Google Form which can be accessed here:

8. Bids must be duly received by the BAC Secretariat through the options given below and as indicated in Section III - Bidding Data Sheet, ITB Clause 15 of this bidding documents, on or before **September 28, 2022 (Wednesday) at 09:30 am**.

 - (ii) both (manual and electronic submission at bac.eps@bfar.da.gov.ph via BFAR Online bidding procedure);
9. Bids must be duly received by the BAC Secretariat through electronic submission in accordance with the BFAR BAC procedure for online bidding stated in Annex A simultaneously with the submission of the printed copies as indicated in the BDS Clause 15. The deadline of manual submission and receipt of bids is on **September 28, 2022 (Wednesday) at 09:30 am** at the 2/F BFAR Bldg., BAC Office, Bureau of Plant Industry Compound, Visayas Ave., Diliman, Q.C while the electronic documents shall be submitted at the bac.eps@bfar.da.gov.ph
10. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.

11. Bid opening shall be held through a video conference call using Zoom application on **September 28, 2022 (Wednesday) at 10:00 am**. Bids will be opened in accordance with the BFAR BAC procedure for online bidding stated in Annex A. Late bids shall not be accepted.
12. Bidders are advised to submit their bids in accordance with the BFAR BAC procedure for online bidding as well as for the printed copies as provided under ITB Clause 10 and Clause 11.

After the opening and evaluation of bids, the BAC, its staff and personnel, Secretariat and Technical Working Group (TWG), as well as Observers are prohibited from making or accepting any communication with any bidder regarding the evaluation of their bids until issuance of Notice of Award (NOA). However, the BAC, through its Secretariat, may ask in writing the bidder for clarification of its request in writing. All responses to requests for clarification shall be in writing.

13. The DA-BFAR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
