A RESOLUTION DECLARING FAILURE OF COMPETITIVE BIDDING CONDUCTED FOR BID REFERENCE NO. 2022-34 ENTITLED "CONSULTANCY SERVICE FOR THE REVIEW AND UPDATING OF THE COMPREHENSIVE POST HARVEST, MARKETING AND ANCILLARY INDUSTRIES PLAN (CPHMAIP) FOR FY 2023 TO 2027 AND WITH AN APPROVED BUDGET FOR THE CONTRACT (ABC) OF FIVE MILLION PESOS (\$\frac{1}{2}\$5,000,000.00)" AND CANCELLING PURCHASE REQUEST NO. 22-07-676 FOR THE PREVIOUSLY MENTIONED PROCUREMENT PROJECT FOR THE CONSULTANCY SERVICES

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) and on the Bureau's website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;

whereas, six (6) prospective bidders viewed the invitation posted at the PhilGEPS namely: (1) Technoearth Systems Corporation, (2) People Dynamics, Inc., (3) Orient Integrated Development Consultants Inc., (4) Asian Social Project Services, Inc. (ASPSI), (5) University of the Philippines Los Baños Foundation Inc., and (6) Infoshare Management Systems;

whereas, on 15 July 2022, the Pre-Procurement Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2 /F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City;

whereas, on 18 July 2022, the re-Pre-Procurement Conference was conducted to discuss the modification in the Terms of Reference such as the rating system, qualifications, and position of the consultants among others, for the finalization of the Bidding Document before posting the latter online and in conspicuous places within the BFAR premises;

whereas, on 27 July 2022, due to the Earthquake, a notice of postponement and rescheduling of the Opening of the Eligibility documents for Shortlisting was posted on BFAR and PhilGEPS website;

WHEREAS, on 28 July 2022, the opening of Eligibility Documents (Shortlisting) for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City attended by (1) Pacific Rim Innovation and Management Exponents, Inc. (Primex) and (2) Ergons Project Marketing Consultant;

WHEREAS, on 02 August 2022, the Summary of TWG Eligibility Scoring for Shortlisting was submitted to the BAC recommending both (1) Pacific Rim Innovation and Management Exponents, Inc. (Primex) and (2) Ergons Project Marketing Consultant to be included in the Shortlist of consulting firms to submit the Technical and financial proposals;

whereas, on the same day, 02 August 2022, a Notice of Eligibility and Shortlisting was emailed to both (1) Pacific Rim Innovation and Management Exponents, Inc. (Primex) and (2) Ergons Project Marketing Consultant, and SBB No. 1 was posted to the BFAR and PhilGEPS website;

whereas, on 04 August 2022, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein (1) Pacific Rim Innovation and Management Exponents, and (2) Ergons Project Marketing Consultant participated;

WHEREAS, on 05 August 2022, SBB No. 2 was posted on the BFAR and PhilGEPS website;

whereas, on 16 August 2022, the opening of bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein no bidder submitted the bid:

whereas, on 17 August 2022, the end-user submitted a cancellation of purchase request for the consultancy services for the review and updating of the Comprehensive Post Harvest Marketing and Ancialliary Industries Plan;

NOW, THEREFORE, FOR AND IN CONSIDERATION OF THE FOREGOING, the members of the **BFAR Bids and Awards Committee (BFAR-BAC)** hereby RESOLVED:
