CONTRACT AGREEMENT FOR INFRASTRUCTURE PROJECTS

THIS AGREEMENT made this SEP 05 2022 2022 between **DEPARTMENT OF AGRICULTURE – BUREAU OF FISHERIES AND AQUATIC RESOURCES (DA – BFAR)** of Fisheries Building Complex, Bureau of Plant Industry Compound, Visayas Avenue, Diliman, Quezon City, Philippines 1101 (hereinafter called “the Entity”) and **ZANEYA BUILDERS & SUPPLY** of 26 Dominga Village, Brgy. WHEREAS, the Entity is desirous that the Contractor execute “**REPAIR AND REHABILITATION OF ASIAN FISHERIES ACADEMY (AFA) AT BFAR – NFDC BINLOC, DAGUPAN**” with **BID REFERENCE NO. 2022 – 35** (hereinafter called “the Works”) and the Entity has accepted the Bid for **ONE MILLION TWO HUNDRED FORTY THOUSAND PESOS ONLY (PhP1,240,000.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
