RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2022-38 SUPPLY, INSTALLATION & COMMISSIONING OF STAND-BY GENERATOR SET WITH COMPLETE ACCESSORIES AND CABLING FOR MAIN BUILDING TO MULTI-FOLD LINKS INC. AS THE BIDDER WHO OFFERED THE SINGLE CALCULATED AND RESPONSIVE BID

WHEREAS, Purchase Request No. **22-07-650** pertains to the Supply, Installation & Commissioning of Stand-By Generator Set with Complete Accessories and Cabling for Main Building in the amount of Php 12,336,517.27;

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference no. 8891017, the Bureau's website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;

WHEREAS, on August 10, 2022 (Wednesday), 11:00 am, the Pre-bid Conference was conducted by the Bids and Awards Committee (BAC) at the BAC Office, 2nd Flr Fisheries Building Complex Brgy. Vasra, Visayas Ave., Quezon City and through video-conferencing via "Zoom" application, and was participated by the lone bidder, Multi-Fold Links Inc.;

WHEREAS, the opening of bids was conducted last September 02, 2022 (Friday), 09:00 am at the BAC Office, 2nd Flr Fisheries Building Complex Brgy. Vasra, Visayas Ave., Quezon City and through video-conferencing via "Zoom" application, and was participated by the lone bidder, Multi-Fold Links Inc.;

WHEREAS, during the opening of the Eligibility and Technical Envelopes, Multi-Fold Links Inc., the lone bidder, "PASSED" the evaluation and was declared eligible for the opening of the financial envelopes;

WHEREAS, during the opening of the Financial Documents of the above-mentioned bidder, their respective bid proposals "As Read" is as follows:

WHEREAS, the BAC, upon due consideration on the Report of the TWG, resolved to adopt the same and recommend the awarding of contract to **MULTI-FOLD LINKS INC.** for being the Single Calculated and Responsive Bidder;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement project under Bid Reference No. 2022-38 SUPPLY, INSTALLATION & COMMISSIONING OF STAND-BY GENERATOR SET WITH COMPLETE ACCESSORIES AND CABLING FOR MAIN BUILDING is recommended to be awarded to MULTI-FOLD LINKS INC. for being the Single Calculated & Responsive Bid in the amount of TWELVE MILLION THREE HUNDRED TWENTY-SIX THOUSAND FIVE HUNDRED EIGHTEEN PESOS (Php 12,326,518.00) ONLY.
