- WHEREAS, the opening of bids was conducted last August 25, 2022 (Thursday), 09:00 am at the BAC Office, 2nd Flr Fisheries Building Complex Brgy. Vasra, Visayas Ave., Quezon City and through video-conferencing via "Zoom" application, and was participated by the lone bidder, Multi-Fold Links Inc.;
