**CONTRACT AGREEMENT FOR GOODS & SERVICES**

THIS AGREEMENT made on this OCT 11 2022 day of \_\_\_\_\_ 2022 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **JOSEFA SLIPWAYS INC.** 1326 M. Naval St., San Roque Navotas City (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **2022-49 entitled "PROCUREMENT OF MATERIALS FOR THE FABRICATION OF PURSE SEINE FISHING GEAR AND HAULING MACHINERIES FOR THE 2 UNITS 21-METERS STEEL-HULLED FISHING BOAT UNDER THE PROJECT "CAPACITATING MUNICIPAL FISHERMEN NATIONWIDE"** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWENTY-THREE MILLION THREE HUNDRED EIGHTY-NINE THOUSAND NINE HUNDRED EIGHTY-SEVEN AND 26/100 PESOS (Php 23,389,987.26) ONLY** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


