WHEREAS, the opening of bids was conducted last **September 28, 2022 Wednesday) at 09:00am** at the BAC Office, 2nd Flr Fisheries Building Complex Brgy. Vasra, Visayas Ave., Quezon City and through video-conferencing via “Zoom” application, which was participated by the following bidder by **JOSEFA SLIPWAYS INC.;**

WHEREAS, during the opening of the Eligibility and Technical Envelopes the above-mentioned bidder “PASSED” the evaluation and was declared eligible for the opening of the financial envelopes;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement project under Bid Reference No. 2022-49 entitled PROCUREMENT OF MATERIALS FOR THE FABRICATION OF PURSE SEINE FISHING GEAR AND HAULING MACHINERIES FOR THE 2 UNITS 21-METERS STEEL-HULLED FISHING BOAT UNDER THE PROJECT “CAPACITATING MUNICIPAL FISHERMEN NATIONWIDE”
