**A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT OF BID REFERENCE NO. 2022 - 51 ENTITLED "SUPPLY AND DELIVERY OF FIBERGLASS - REINFORCED PLASTIC (FRP) SUPPLIES AND MATERIALS, FABRICATION TOOLS AND ACCESORRIES, UNDERWATER FITTINGS AND 16 HP MARINE GASOLINE ENGINE FOR THE CONSTRUCTION OF 610 UNITS 30 - FOOTER FRP BOATS FOR THE LIVELIHOOD INTERVENTION NATIONWIDE".**

**WHEREAS,** the Bureau of Fisheries and Aquatic Resources - Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the procurement project entitled "**SUPPLY AND DELIVERY OF FIBERGLASS - REINFORCED PLASTIC (FRP) SUPPLIES AND MATERIALS, FABRICATION TOOLS AND ACCESORRIES, UNDERWATER FITTINGS AND 16 HP MARINE GASOLINE ENGINE FOR THE CONSTRUCTION OF 610 UNITS 30 - FOOTER FRP BOATS FOR THE LIVELIHOOD INTERVENTION NATIONWIDE**" (herein referred to as "Procurement Project") consisting of four (4) lots through posting in the Philippine Government Electronic Procurement Service (PhilGEPS), in the Bureau's website ([www.bfar.da.gov.ph](http://www.bfar.da.gov.ph)) and in conspicuous places within the Bureau's premises for seven (7) days;

**WHEREAS,** on 16<sup>th</sup> day of September 2022, Friday at 01:30 P.M. the Pre-bidding Conference for the Procurement Project was held through video-conferencing via "Zoom" application;

**WHEREAS,** there were eleven (11) bidders attended in the said Pre-Bid conference:

1. **PAKKVA MARINE PRODUCTS;**
2. **IZZO INDUSTRIAL SUPPLY;**
3. **I.F. CLEMENTE CONSTRUCTION CORPORATION;**
4. **ALL CERTIFIED EQUIPMENT TRADING CORPORATION;**
5. **HLYC TRADING;**

6. **PROPMECH CORPORATION;**
7. **GOLDEN CHAIN MARINE ENGINEERING SERVICES;**
8. **CHILL – PERSHA ENTERPRISE;**
9. **DYNAMIC POWER AND MARINE INDUSTRIAL HARDWARE INC.;**
10. **DYNACAST SHIPBUILDING & REPAIRS, INC.; AND**
11. **P.I. FARM PRODUCTS, INC.**

**WHEREAS,** on 21<sup>st</sup> day of September 2022, the BAC posted a Supplemental/Bid Bulletin No. 1, amending and clarifying information in the bidding documents, that were posted on the PhilGEPS and BFAR website for at least seven (7) consecutive calendar days before the deadline for submission and opening of bids, pursuant to Section 22.5.2 of the IRR of RA 9184;

**WHEREAS,** on 29<sup>th</sup> day of September 2022, Thursday at 10:00 A.M., the opening of bids for the Procurement Project was held through video-conferencing via “Zoom” application;

**WHEREAS,** in the said Bid Opening, there were four (4) bidders submitted their bid envelopes namely:

1. **POLYMER PRODUCT PHILIPPINES, INC. – (LOT NO. 1 & 2);**
2. **I.F. CLEMENTE CONSTRUCTION CORPORATION – (LOT NO. 1, 2 & 3);**
3. **CHILL – PERSHA ENTERPRISE – (LOT NO. 3); and**
4. **ALL CERTIFIED EQUIPMENT TRADING CORPORATION – (LOT NO. 4)**

**WHEREAS,** in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes, the above-mentioned bidders were “PASSED” and declared eligible for the opening of the financial bid envelopes;

**WHEREAS,** during the opening of the financial bid envelopes submitted by the bidders its bids were read and tabulated as follows:

**WHEREAS,** after reading and determining the amount of bids as proposed by the qualified bidders, the BAC declared the offer of **POLYMER PRODUCT PHILIPPINES, INC.** for **Lot No. 1 and 2**, **CHILL – PERSHA ENTERPRISE** for **Lot No. 3** as Lowest bid as read and **ALL CERTIFIED EQUIPMENT TRADING CORPORATION** as Single bid as read for **Lot No. 4**, the said procurement project will be subjected to post bidding evaluation and post qualification process to be conducted by the Technical Working Group (TWG);

**WHEREAS,** the BAC ordered the BAC Secretariat to forward the copies of the Eligibility, Technical and Financial envelopes of the bidder/s to the TWG for detailed evaluation and post-qualification process;

**WHEREAS,** the TWG submitted the bid evaluation report stating *inter alia* their recommendation for the conduct of the post-qualification process on the offer of **POLYMER PRODUCT PHILIPPINES, INC.** for **Lot No. 1 and 2**, **CHILL – PERSHA ENTERPRISE** for **Lot No. 3** and **ALL CERTIFIED EQUIPMENT TRADING CORPORATION** for **Lot No. 4**;

**WHEREAS,** the post qualification documents submitted by the Lowest and Single calculated and responsive bidder/s were transmitted to the TWG;

**WHEREAS,** the TWG recommended in the post qualification report to award the Procurement Project to **POLYMER PRODUCT PHILIPPINES, INC.** for **Lot No. 1 and 2**, **CHILL – PERSHA ENTERPRISE** for **Lot No. 3** for being the Lowest Calculated and Responsive Bidder and to **ALL CERTIFIED EQUIPMENT TRADING CORPORATION** for **Lot No. 4** for being the Single Calculated and Responsive Bidder;

**WHEREAS,** the BAC, after due consideration on the report of the TWG, resolved to adopt the same and recommend the awarding of contract to **POLYMER PRODUCT PHILIPPINES, INC.** for **Lot No. 1 and 2**, **CHILL – PERSHA ENTERPRISE** for **Lot No. 3** and **ALL CERTIFIED EQUIPMENT TRADING CORPORATION** for **Lot No. 4**;

**NOW, THEREFORE**, we, the members of the BAC, hereby **RESOLVED**, as it is hereby **RESOLVED** the following:

1. The Procurement of the Project for **Lot No. 1 and 2** with **Bid Reference No. 2022 - 51** entitled **"SUPPLY AND DELIVERY OF FIBERGLASS - REINFORCED PLASTIC (FRP) SUPPLIES AND MATERIALS, FABRICATION TOOLS AND ACCESORRIES, UNDERWATER FITTINGS AND 16 HP MARINE GASOLINE ENGINE FOR THE CONSTRUCTION OF 610 UNITS 30 - FOOTER FRP BOATS FOR THE LIVELIHOOD INTERVENTION NATIONWIDE"**, be awarded to **POLYMER PRODUCT PHILIPPINES, INC.**, for being the bidder who offered the Lowest Calculated and Responsive Bid in the total amount of **TWENTY - FIVE MILLION SIX HUNDRED FORTY THOUSAND FOUR HUNDRED EIGHTY - NINE AND 58/100 (PhP25,640,489.58)** and the Notice of Award be issued to **POLYMER PRODUCT PHILIPPINES, INC.**, for the preparation of the contract agreement, Notice to Proceed and commencement of the delivery of the Goods;
2. The Procurement of the Project for **Lot No. 3** with **Bid Reference No. 2022 - 51** entitled **"SUPPLY AND DELIVERY OF UNDERWATER FITTINGS FOR THE CONSTRUCTION OF 610 UNITS 30 - FOOTER FRP BOATS FOR THE LIVELIHOOD INTERVENTION NATIONWIDE"**, be awarded to **CHILL - PERSHA ENTERPRISE**, for being the bidder who offered the Lowest Calculated and Responsive Bid in the total amount of **FIVE MILLION NINE HUNDRED TWELVE THOUSAND ONE HUNDRED TWENTY PESOS ONLY (PhP5,912,120.00)** and the Notice of Award be issued to **CHILL - PERSHA ENTERPRISE**, for the preparation of the contract agreement, Notice to Proceed and commencement of the delivery of the Goods; **and**
3. The Procurement of the Project for **Lot No. 4** with **Bid Reference No. 2022 - 51** entitled **"SUPPLY AND DELIVERY OF 16 HORSEPOWER MARINE GASOLINE ENGINE FOR THE CONSTRUCTION OF 610 UNITS 30 - FOOTER FRP BOATS FOR THE LIVELIHOOD INTERVENTION NATIONWIDE"**, be awarded to **ALL CERTIFIED EQUIPMENT TRADING CORPORATION**, for being the bidder who offered the Single Calculated and Responsive Bid in the total amount of **EIGHTEEN MILLION FIFTY - SIX THOUSAND PESOS ONLY (PhP18,056,000.00)** and the Notice of Award be issued to **ALL CERTIFIED EQUIPMENT TRADING CORPORATION**, for the preparation of the contract agreement, Notice to Proceed and commencement of the delivery of the Goods.
