THIS AGREEMENT made on this \_\_\_ day of \_\_\_\_\_ 2022 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **MULTI-FOLD LINKS INC.** Platinum 2000, No. 7 Annapolis Street, Greenhills, San Juan City (hereinafter called "the Supplier") of the other part:

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **FORTY-ONE MILLION FOUR HUNDERED FORTY-SIX THOUSAND TWO HUNDRED EIGHTEEN PESOS (Php 41,446,21.800) ONLY** or such other sums as may be ascertained, **MULTI-FOLD LINKS INC.** agrees to the project **2022-52** entitled "**BFAR MAIN BUILDING ANCILLARY SYSTEM MODERNIZATION**" in accordance with his/her/its Bid.

4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms **IN WITNESS** whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
