RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2022-52 BFAR MAIN BUILDING ANCILLARY SYSTEM MODERNIZATION TO MULTI-FOLD LINKS INC. AS THE BIDDER WHO OFFERED THE SINGLE CALCULATED AND RESPONSIVE BID

- WHEREAS, Purchase Request No. 22-09-922 pertains to the BFAR Main Building Ancillary System Modernization in the amount of Php 41,454,362.68;
- WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference no. **8995394**, the Bureau's website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;
- WHEREAS, on September 16, 2022 (Friday) at 10:00 am the Pre-bid Conference was conducted by the Bids and Awards Committee (BAC) at the BAC Office, 2<sup>nd</sup> Flr Fisheries Building Complex Brgy. Vasra, Visayas Ave., Quezon City and through video-conferencing via "Zoom" application, and was participated by the lone bidder, Multi-Fold Links Inc.;
- WHEREAS, the opening of bids was conducted last September 28, 2022 (Wednesday) at 01:30 pm at the BAC Office, 2<sup>nd</sup> Flr Fisheries Building Complex Brgy. Vasra, Visayas Ave., Quezon City and through video-conferencing via "Zoom" application, and was participated by the lone bidder, Multi-Fold Links Inc.;
- WHEREAS, during the opening of the Eligibility and Technical Envelopes, Multi-Fold Links Inc., the lone bidder, "PASSED" the evaluation and was declared eligible for the opening of the financial envelopes;
- WHEREAS, during the opening of the Financial Documents of the above-mentioned bidder, their respective bid proposals "As Read" is as follows:

- **WHEREAS,** the BAC, upon due consideration on the Report of the TWG, resolved to adopt the same and recommend the awarding of contract to **MULTI-FOLD LINKS INC.** for being the Single Calculated and Responsive Bidder;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement project under Bid Reference No. 2022-52 BFAR MAIN BUILDING ANCILLARY SYSTEM MODERNIZATION is recommended to be awarded to MULTI-FOLD LINKS INC. for being the Single Calculated & Responsive Bid in the amount of FORTY-ONE MILLION FOUR HUNDERED FORTY-SIX THOUSAND TWO HUNDRED EIGHTEEN PESOS (Php 41,446,21.800) ONLY.
