**A RESOLUTION RECOMMENDING AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2022-03 ENTITLED "SUPPLY AND DELIVERY OF AUTOMOTIVE DIESEL OIL (ADO), GASOLINE AND LUBRICANTS FOR M/V DA-BFAR, MCS PATROL VESSELS, F/B TAMBAKOL AND MULTI MISSION OFFSHORE VESSELS FOR FY 2022" TO PETRON CORPORATION FOR BEING THE SINGLE CALCULATED AND RESPONSIVE BIDDER.**

**WHEREAS,** the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of *one (1)* lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) and in the Bureau's website ([www.bfar.da.gov.ph](http://www.bfar.da.gov.ph)) and in conspicuous places within the Bureau's premises for *seven (7)* days;

**WHEREAS,** two (2) prospective bidders viewed the invitation posted at the PhilGEPS namely: (1) Petron Corporation and (2) Bentrax Builders;

**WHEREAS,** on *23 December 2021*, the Pre-Procurement Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2 /F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City;

**WHEREAS,** on *13 January 2022*, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein only *Petron Corporation* participated.

**WHEREAS,** on *25 January 2022*, the opening of bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein only *Petron Corporation* submitted their bids;

**WHEREAS,** in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes submitted by the



bidder/supplier were "PASSED" and declared eligible for the opening of the financial bid envelope;

**WHEREAS,** the financial bid envelopes submitted was opened and its bid offers is in the amount of ***Sixty-Eight Million Nine Hundred Forty-Seven Thousand Six Hundred Twenty-Seven pesos and 45/100 only (₱ 68,947,627.45);***

**WHEREAS,** after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared the Petron Corporation, offered the single bid as read for the said procurement project and will be subjected to post bidding evaluation and post qualification process to be conducted by the TWG;

**WHEREAS,** in the detailed bid evaluation report submitted by the Technical Working Group (TWG) last *28 January 2022*, it was proposed that the **Petron Corporation** be declared as the *Single Calculated and Responsive Bidder* and therefore recommended to proceed in the conduct of Post Qualification procedure;

**WHEREAS,** on *09 February 2022*, the result of the post-qualification of compliance to the technical specification by **Petron Corporation**, for being the Single Calculated and Responsive Bidder (SCRB);

**WHEREAS,** the BAC, upon due consideration on the report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of contract to **Petron Corporation**;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED,** that the procurement of the project with Bid Reference No. 2022-03 entitled "SUPPLY AND DELIVERY OF AUTOMOTIVE DIESEL OIL (ADO), GASOLINE AND LUBRICANTS FOR M/V DA-BFAR, MCS PATROL VESSELS, F/B TAMBAKOL AND MULTI MISSION OFFSHORE VESSELS FOR FY 2022", be awarded to PETRON CORPORATION in the amount of **SIXTY-EIGHT MILLION NINE HUNDRED FORTY-SEVEN THOUSAND SIX HUNDRED TWENTY-SEVEN PESOS AND 45/100 ONLY (₱ 68,947,627.45)** for being the bidder who offered the *Single Calculated and Responsive Bid*;

**RESOLVED FINALLY** that the Notice of Award be issued to the above-stated bidder, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.
