CONTRACT AGREEMENT FOR GOODS & SERVICES

2022 between the BUREAU OF THIS AGREEMENT made on this FISHERIES AND AQUATIC RESOURCES (BFAR) of the Philippines (hereinafter called "the Entity") of the one part and PROPMECH CORPORATION of Marine Technology Center Building, A. Soriano corner Arzobispo Street, Intramuros, Manila (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., Bid Reference No. 2022-22 (Lot 1) entitled "SUPPLY AND DELIVERY OF VARIOUS MAINTENANCE PARTS FOR MAIN AND AUXILIARY ENGINES AND SKIFF BOAT OF M/V DA-BFAR" and (Lot 4) entitled "SUPPLY, DELIVERY, AND LABOR OF OVERHAULING FOR REINTJES TRANSMISSION - WVS 334L STARBOARD MARINE GEARBOX OF DA-BFAR MCS 3009 PATROL VESSEL" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of ONE MILLION TWO HUNDRED FIFTY-SEVEN THOUSAND AND EIGHT HUNDRED FORTY-SIX PESOS ONLY (P 1,257,846.00) for Lot No. 1 and ONE MILLION NINE HUNDRED SEVENTY-THREE THOUSAND THREE HUNDRED SEVENTY-SIX PESOS AND 90/100 (P 1,973,376.90) for Lot No. 4 (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - Schedule of Requirements;
 - Technical Specifications; ii.
 - General and Special Conditions of Contract; and
 - Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. The winning bidder agrees that

additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of ONE MILLION TWO HUNDRED FIFTY-SEVEN THOUSAND AND EIGHT HUNDRED FORTY-SIX PESOS ONLY (₱ 1,257,846.00) for Lot No. 1 and ONE MILLION NINE HUNDRED SEVENTY-THREE THOUSAND THREE HUNDRED SEVENTY-SIX PESOS AND 90/100 (# 1,973,376.90) for Lot No. 4 or such other sums as may be ascertained, PROPMECH CORPORATION agrees to execute in accordance with his/her/its Bid.
- 4. The BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
