CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made on this 12 day of OCT 2022 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **CRISMAR GENERAL MERCHANDISE** Gorordo Ave., Cebu City (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Bid Reference No. 2022-31 entitled "SUPPLY AND DELIVERY OF UNIFORM TO BFAR FISHERIES QUARANTINE OFFICERS"** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SEVEN HUNDRED FORTY-TWO THOUSAND THREE HUNDRED FORTY-FOUR PESOS AND NINETY CENTAVOS ONLY (PhP 742,344.90)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security;
 - (g) the Entity's Notice of Award and;
 - (h) the Certificate of Availability of Funds (CAF)
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
