**A RESOLUTION RECOMMENDING AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2022-31 "SUPPLY AND DELIVERY OF UNIFORM TO BFAR FISHERIES QUARANTINE OFFICERS" TO CRISMARK GENERAL MERCHANDISE FOR BEING THE LOWEST RESPONSIVE CALCULATED BIDDER.**

**WHEREAS,** the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the procurement project **UNDER BID REFERENCE NO. 2022-31** entitled **"SUPPLY AND DELIVERY OF UNIFORM TO BFAR FISHERIES QUARANTINE OFFICERS"** (herein referred to as "Procurement Project") consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference no. 8760580, in the Bureau's website ([www.bfar.da.gov.ph](http://www.bfar.da.gov.ph)) and in conspicuous places within the Bureau's premises for seven (7) days;

**WHEREAS,** on 23 June 2022 at 11:00 am the Pre-Bid Conference for the Procurement Project was held at the BFAR BAC Office, 2<sup>nd</sup> Floor Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City and *via ZOOM Meeting Application*;

**WHEREAS,** on 24 June 2022, a Supplemental Bid Bulletin No. 1 was issued and posted in the Philippine Government Electronic Procurement Service (PhilGEPS), in the Bureau's website ([www.bfar.da.gov.ph](http://www.bfar.da.gov.ph)), in conspicuous places within the Bureau's premises;

**WHEREAS,** on 05 July 2022, 1:30 pm, the opening of bids for the Procurement Project was held at the BFAR BAC Office, 2<sup>nd</sup> Floor Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City and *via ZOOM Meeting Application*;

**WHEREAS,** in the said Bid Opening, five (5) bidders submitted their bid envelopes, namely **CRISMARK GENERAL MERCHANDISE, ENGLAND TEXTILES, LA MARINA ENTERPRISES, INC., ZHUJAR MFG. INC. and KATE ANGELO FASHION**;

**WHEREAS,** in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes submitted by the bidders/suppliers only three (3) "PASSED" and declared eligible for the opening of the financial bid envelopes;

**WHEREAS,** during the opening of the financial bid envelopes submitted by the bidders its bids were read and tabulated as follows:

**WHEREAS,** after reading and determining the amount of bids as proposed by the qualified bidder/s, the BAC declared the offer of **CRISMARK GENERAL MERCHANDISE** as the lowest bid as read for the said procurement project will be subjected to detailed bid evaluation and post qualification process to be conducted by the TWG;

**WHEREAS,** the BAC ordered that the copies of the Eligibility, Technical and Financial envelopes of the bidder be forwarded to the TWG for detailed bid evaluation and post-qualification process;

**WHEREAS,** the Technical Working Group (TWG) submitted the bid evaluation report stating *inter alia* their recommendation for the conduct of the post-qualification process on the offer of **CRISMARK GENERAL MERCHANDISE**;

**WHEREAS,** the post qualification documents submitted by the **CRISMARK GENERAL MERCHANDISE** as lowest calculated bidder were transmitted to the TWG;

**WHEREAS,** the TWG recommending the post qualification report that the award for the Procurement Project be given to **CRISMARK GENERAL MERCHANDISE** as *Lowest Calculated and Responsive Bidder with the Technical Specification*;

**WHEREAS,** the BAC, after due consideration on the report of the TWG, resolved to adopt the same and recommend the awarding of contract to **CRISMARK GENERAL MERCHANDISE**;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED,** that the procurement of the project with Bid Reference No. 2022-31 entitled **"SUPPLY AND DELIVERY OF UNIFORM TO BFAR FISHERIES QUARANTINE OFFICERS"** to **CRISMARK GENERAL MERCHANDISE** for being the Lowest Calculated and Responsive Bid in the total amount **SEVEN HUNDRED FORTY-TWO THOUSAND THREE HUNDRED FORTY-FOUR PESOS AND NINETY CENTAVOS ONLY (PhP 742,344.90)**.






