RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2022-32A ENTITLED SUPPLY AND INSTALLATION OF DISTRIBUTION POLE AND ACCESSORIES (RE-BID) TO JD LEGASPI CONSTRUCTION AS THE BIDDER WHO OFFERED THE SINGLE CALCULATED AND RESPONSIVE BID

WHEREAS, Purchase Request No. **22-06-584** pertains to the Construction of additional primary distribution pole for the switching, metering and protection of BFAR Building Complex Primary Distribution System amounting to **Php 1,850,923.41**;

WHEREAS, Resolution No. 2022-32 dated July 08, 2022 pertains to the failure of bidding due to non-submission of bids during the Bid Opening last July 05, 2022;

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Bureau’s website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau’s premises for seven (7) days;

WHEREAS, on July 19, 2022 (Tuesday), 10:00 am, the Pre-bid Conference was conducted by the Bids and Awards Committee (BAC) at the BAC Office, 2nd Flr Fisheries Building Complex Brgy. Vasra, Visayas Ave., Quezon City and through video-conferencing via “Zoom” application, and was participated by the lone bidder, JD Legaspi Construction;

WHEREAS, the opening of bids was conducted last August 04, 2022 (Monday), 09:00 am at the BAC Office, 2nd Flr Fisheries Building Complex Brgy. Vasra, Visayas Ave., Quezon City and through video-conferencing via “Zoom” application, and was participated by the lone bidder, JD Legaspi Construction;

WHEREAS, during the opening of the Eligibility and Technical Envelopes, JD Legaspi Construction, the lone bidder, “PASSED” the evaluation and was declared eligible for the opening of the financial envelopes;

WHEREAS, during the opening of the Financial Documents of the above-mentioned bidder, their respective bid proposals “As Read” is as follows:

WHEREAS, after the opening of the financial documents, the copy of the Technical and Financial envelopes of the qualified bidder was turned-over to the Technical Working Group (TWG) for post- bid evaluation;

WHEREAS, the TWG submitted their Post-Bid Evaluation Report dated August 15, 2022 verify the authenticity of the documents submitted by **JD LEGASPI CONSTRUCTION;**

WHEREAS, in the Post-Qualification Report submitted by the TWG dated August 18, 2022 the TWG recommended the award be given to **JD LEGASPI CONSTRUCTION** for being the Single Calculated and Responsive Bidder;

WHEREAS, a copy of the said report is hereby made an integral part of the Resolution;

WHEREAS, the BAC, upon due consideration on the Report of the TWG, resolved to adopt the same and recommend the awarding of contract to **JD LEGASPI CONSTRUCTION** for being the Single Calculated and Responsive Bidder;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement project under Bid Reference No. 2022-32A ENTITLED SUPPLY AND INSTALLATION OF DISTRIBUTION POLE AND ACCESSORIES (RE-BID) is recommended to be awarded to JD LEGASPI CONSTRUCTION for being the Single Calculated & Responsive Bid in the amount of ONE MILLION EIGHT HUNDRED FORTY THOUSAND FOUR HUNDRED SEVENTY-EIGHT AND 74/100 (Php 1,840,478.74) ONLY.

RESOLVED FINALLY that, the Notice of Award be issued to **JD LEGASPI CONSTRUCTION** for the preparation of the Contract Agreement, Notice to Proceed and commencement to the project.
